

## **Advantage Terms and Conditions 2018-2019**

### **1. General Conditions**

- 1.1. These terms and conditions define the rules, scope and conditions of participation in the examinations member scheme offered by the British Council in Croatia, hereafter referred to as “Addvantage”.
- 1.2. The Addvantage member scheme is fully owned and operated by the British Council.
- 1.3. The Addvantage member scheme recognises schools and institutions which register candidates for Cambridge English Qualifications through the online registration system REX.

### **2. Rules for participation**

- 2.1. For the academic year, 1 September 2018 to 31 August 2019, the level of membership is defined by the total number of registrations for paper-based and computer-based exam registrations for Cambridge English Qualifications made with the British Council in Croatia in the period 1 April 2017 to 31 August 2018.
- 2.2. The total number of registrations during that period entitles members to the benefits according to their level of membership mentioned above.
- 2.3. The Addvantage member logo can be used as per the validity period mentioned in these Terms and Conditions.
- 2.4. There are no fees associated with a school’s or institution’s membership.
- 2.5. Addvantage membership will be activated after you have registered candidates for Cambridge English Qualifications through the online registration system REX. You will receive confirmation of your membership by email from the British Council examinations team from 01 September 2018.
- 2.6. Addvantage membership is automatically extended when you register candidates for Cambridge English Qualifications with us in the next academic year and is valid until cancellation. Your membership level is revaluated at the beginning of each academic year and can change depending on the number of registrations of candidates for Cambridge English Qualifications you make.
- 2.7. Members have the right to terminate membership at any point. This should be done in writing to the British Council examinations team: [exams@britishcouncil.hr](mailto:exams@britishcouncil.hr). Membership will cease from the moment the British Council receives notification by

email. You will receive confirmation of the termination of your membership by email within 10 days.

- 2.8. From the moment membership is terminated, all entitlement to benefits of the scheme will cease and members are obliged to remove the Addvantage member logo from their website or return the Addvantage certificate and refrain from referring to the Addvantage member scheme from thereon.
- 2.9. Membership will not be extended to the following year in the event a member has not registered any candidates for Cambridge English Qualifications with the British Council in Croatia in the current year.
- 2.10. Benefits not used by the end of the academic year will expire and cannot be carried forward to the following year.

### **3. Termination and amendments**

- 3.1. The British Council reserves the right to end the member scheme prior to the date mentioned in section 4 or to extend it beyond this date upon relevant notice.
- 3.2. The British Council reserves the right to introduce amendments to these regulations and undertakes to inform the members if the scheme of such amendments by email. Such amendments will be valid and effective as of the date of the notification to the members or at any later date stated by the British Council in the relevant notification.
