

Broj kandidata koji želi koristiti B2 First, C1 Advanced, C2 Proficiency certifikate u svrhu imigracije, zapošljavanja te visokog obrazovanja raste, stoga ih je na dan ispita potrebno fotografirati kako bi se podigla razina sigurnosti i vjerodostojnosti ispita te omogućilo organizacijama (fakultetima, poslodavcima, ambasadama, ministarstvima unutarnjih poslova, imigracijskim uredima) da imaju pristup rezultatima kandidata.

Fotografija svakog kandidata strogo je povjerljiva. Cambridge Assessment English drži fotografije i osobne podatke kandidata u svojoj bazi podataka u Cambridgeu. Fotografija snimljena na dan ispita, kao i kandidatov rezultat, ime i prezime, datum rođenja i spol bit će dostupni na internet stranici za sigurnu provjeru rezultata (Online Results Verification site). Pristup tome imaju samo one organizacije koje trebaju provjeriti rezultat kandidata, a kojima kandidat dozvoli pristup.

Kandidatima koji ispit polažu u svrhu **emigracije** mora se na dan ispita osim fotografije snimiti i glas i to tako da ih se snimi dok čitaju za to predviđen tekst. Pročitani tekst nema veze s ispitom, ne ocjenjuje se ni na koji način, a služi isključivo za potrebe identifikacije kandidata.

Nije moguće pristupiti ispitu bez potpisane suglasnosti za fotografiranje. Svojim potpisom kandidat potvrđuje da je suglasan s navedenim.

Za kandidate mlađe od 18 godina na dan ispita, suglasnost mora dati roditelj ili skrbnik.

The number of candidates wishing to use their B2 First, C1 Advanced and C2 Proficiency qualifications for purposes such as immigration and access to work and higher education is on the rise. Test day photography has been introduced in order to raise the level of exam security and to help organisations (universities, employers, embassies, interior ministries, immigration authorities) to have access to examination results.

The photograph is strictly confidential and stored in Cambridge Assessment English along other candidate data. The photo taken on the day of the test, as well as the candidate's result, name, date of birth and gender, will be available on the secure Online Results Verification website for use by organisations wishing to verify the results. Candidates will be able to control who can access their results and view their photos.

Candidates taking the exam for **emigration** purposes will also have their voice recorded on the day of the exam. They will be asked to read a short text. The recorded reading of the text is in no way connected to the exam and is not assessed. It is for identification purposes only.

Without signing this consent form candidates cannot take the exam. By signing the form on the following page the candidate consents to the aforementioned.

For candidates who are under 18 on the day of the exam, consent should be given by a parent or guardian.
